Warnings over €8k 'parental alienation' reports after children are placed in custody of abusive parent

A FAMILY court expert is charging €8,000 to compile reports recommending that children in some custody battles are placed in the care of fathers accused of abusing them.

The revelation comes as an Irish Mail on

Sunday investigation uncovered several cas Sunday investigation uncovered several cases in which women have lost custody of their children after they were accused of 'parental alienation' by family therapist Jim Sheehan. The role of Mr Sheehan – who has been investigated for wrongly introducing himself

as a 'social worker' - in the family courts has been raised in the Dáil on several occasions.

Fine Gael TD Bernard Durkan warned that if the 'activities of Mr Jim Sheehan in the courts are allowed to continue, there will be serious consequences'.

'Children are removed from mothers callously'

The MoS has spoken to several mothers who claim Mr Sheehan's evidence – in which he alleged they were 'alienating' their children from their father – resulted in them losing custody rights. They are now forced to pay significant sums of money to a private company for supervised access to their children. The cases in which Mr Sheehan successfully argued that children should be removed from their methers include:

- argued that children should be removed from their mothers include:

 A mother was accused of parental alienation after she raised concerns about her former husband, who was later labelled a 'dangerous' abuser in another jurisdiction;
 A woman whose children alleged they were abused by their father was accused of parental alienation:
- Another woman was savagely assaulted by her former partner, who was then granted custody of their child.

In some cases, mothers were granted super-vised access to their children, for which they

viseu access to their children, for which they then have to pay a private company hundreds of euro a week to facilitate. Some women accused of parental alienation have had to pay extor-tionate legal fees to fight to be reunited with their children. Mr Durkan said that he has come

results in the child victim being silenced, and the protective parent being punished by the State for

supporting their child's disclosure and safety. However, the Family Therapists Association of Ireland (FTAI), of which Mr

Ireland (FTAI), of which Mr Sheehan is a registered member, argues parental alienation is a treatable mental disorder. In a recent research paper, Mr Sheehan said that children who experienced parental alienation spoke of 'missing out on a childhood and their

out on a childhood and their experience of an early loss of innocence'.

Mr Sheehan noted:
'Clinicians treating adults who were sexually abused as children will be aware of the similarity in such experiences

between the two groups.'
In a submission to the

was later withdrawn – Mr
Sheehan wrote that parental
alienation can be perpetrated
by fathers as well as mothers
and is 'not a gendered issue'.

website says it has withdrawn

It added it is 'aware that, as a concept, parental alienation is contested' and it has facilitated the establishment of a working group to 'examine the issues and complexities of the term'.

THE concept of parental alienation is highly contested and opinions are split on whether it exists at all,

whether it exists at all, according to a recent Government policy paper. Some argue it is a concept proposed by abusive parents to further abuse and control the other parent. A 2023 report by the UN's Special Rapporteur on violence against women, Reem Alsalem, said that the concept was 'unfounded and unscientific'. However, others

was 'unfounded and unscientific'. However, others insist parental alienation is a real and painful experience of estrangement from a child. The Government policy paper notes that Jim Sheehan – who was director of family therapy training for the Mater/UCD MSc in Systemic Psychotherapy before he set up his own practice – recommends the transfer of custody to the 'targeted parent' in conjunction with

custody to the 'targeted parent' in conjunction with therapy in cases of confirmed parental alienation. Mr Sheehan was noted as saying 'awarding primary parental responsibility to the targeted parent and providing specialist family therapy is effective in ameliorating effective in amelioratin

no regulations setting out who can conduct Section 47 reports. No minimum qualifications are required for the authors of the reports, who charge significant sums of money for their services.

court cases. The Kildare North TD said: 'I want to draw attention to some-thing else that is equally ominous and worrying. This is use of Sec-tion 47 reports and the degree to which the courts take them into

count.'
le added: 'A court messenger can, by virtue of his or her recommendation to the court, make it possible to take away children from a mother in order to ensure a particular outcome in a forthcom-

particular outcoming case.
This is what it amounts to. I have cases in recent times where mothers have been sepa-rated from their children and sub-

rated from their children and subjected to appalling indifference and callousness by the system.

'Their children are removed callously and put in a place determined by the court.

'I finish by drawing attention to Section 47, which needs to be dealt with soon, because there will be a tragedy.

'There is a level of emotion, trauma and coldness surrounding a mother when she is told that she does not matter in this business or does not matter in this business or does not matter in this business or that if she does matter, it is only in a way decided by somebody else. If the activities of Mr Jim Sheehan in the courts are allowed to con-tinue, there will be serious conse-
