

IRANIANS STRIKE BACK AT U.S. BASE

Trump 'thanks' Iran for warning before it fired a barrage of missiles

DONALD Trump last night 'thanked' Iran for the early warning after a barrage of missiles was fired towards the largest Western military base in the Middle East.

Tehran's threatened response to American strikes on its nuclear facilities came as it sent 14 missiles of its own across the Persian Gulf towards Qatar's Al-Udeid coalition base, which is home to US troops and also the regional headquarters of the British Royal Air Force.

All were shot down without hitting their target, leaving the US president to label it a 'very weak response' to his weekend attack

weekend attack.

He wrote on his Truth Social platform: 'I am pleased to report that NO Americans were harmed, and hardly any damage was done. Most importantly, they've gotten it all out of their "system," and there will, hopefully, be no further HATE. I want to thank Iran for giving us early notice, which made it possible for no lives to be lost, and nobody to be injured.

'Perhaps Iran can now proceed to Peace and Harmony in the Region, and

THE former principal of a special needs school for boys was jailed for four years yesterday after being found guilty of multiple counts of historical child sex abuse which a judge labelled 'atrocities'

St John of God brother Aidan Clohessy, 85, was found guilty of 19 sexual assaults against six boys in two trials held behind

boys in two trials held behind closed doors in May.

Because of reporting restrictions during the trials, the verdicts can only now be reported.

The boys were all pupils at St Augustine's school for intellectually disabled children in Blackrock, south Dublin, where Clohessy was principal until his superiors sent him on a 'career break' to Malawi in 1993.

All of the offences took place at

All of the offences took place at St Augustine's and relate to dates between 1969 and 1986. With some of the offences dating

back as far as 56 years, this is one of the oldest historical abuse

cases ever to be prosecuted.
Clohessy was first exposed as a serial paedophile in a landmark investigation published by our sister newspaper, The Irish Mail on Sunday, in January 2018.

That investigation sparked a new criminal inquiry after victims who cannot read or write recognised Clohessy's photo in the newspaper and came forward.

In previous years, some of those victims had tried to complain to

gardaí only to have their complaint ignored.

The first trial, before Judge Elva

Duffy at the Criminal Courts of Justice in Dublin, took five days and concluded on May 13.

ond trial, this could not be reported until yesterday when sentencing hearings for both tri-als took place.

In the first trial, Clohessy was found guilty of four counts of indecently assaulting Wayne Farrell, 51, of Dún Laoghaire, in the 1980s. The abuse began when he was 11. Clohessy was also found guilty of indecently assaulting guilty of indecently assaulting Gerry Quinn, 52, of Leixlip, Co. Kildare on ten occasions. The

abuse began when he was ten.
One of the convictions relating to Mr Quinn involves penetration during an indecent assault car-

ried out in a residence for pupils at St Augustine's.

During the trial, Mr Quinn told the court Clohessy took down his shorts and underpants, telling him to lean over a church-like bench in a room in a school residence.

'He would call me a demon and say he had to get the demon out of me,' Mr Quinn testified.

Mr Quinn said the assaults

against him stopped only after he threatened Clohessy with a kitchen knife.

In his victim impact statement, which was read by his wife Cathy yesterday, Mr Quinn described the devastating impact the abuse has had on his life. He described feeling 'haunted

by a ghost of your own life, one

that refuses to stay buried.
'I was just a child. A child who trusted the adults who were meant to care for him, protect

St John of God brother is jailed for attacks on boys while he was the principal of special needs school

IN 2013 Phil Gray was one of a dozen management figures at the St John of God group who shared in unauthorised, secret payments worth millions.

The top-up scandal was later exposed by an Irish Mail on Sunday investigation in 2016.

Ms Gray was one of two defence witnesses who were called to testify at both of Brother

Aidan Clohessy's abuse trials.
In her evidence, Ms Gray, who is now retired, testified about being responsible for the 'chalets' that boarders lived in at St Augustine's

school in the 1980s.

Brother Aidan's defence used Ms Gray's testimony in an effort to cast doubt on the evidence of his accusers.

In particular, they used her testimony to argue that Brother Aidan's victims would not have

been left unaccompanied by teachers or key workers when they were allegedly assaulted.

Ms Gray also offered testimony relating to campus locations and living arrangements in the chalets that contradicted the memory of the accusers in the case.

And she told the court that Brother Aidan while principal of St Augustine's and the overall director of services – had no role in managing the chalets.

Another defence witness - Paul Stephens gave similar testimony for the defence.

Mr Stephens, now based in the Middle East, is a retired Department of Education school inspector and former teacher at St Augustines.

'I don't remember him [Brother Aidan] having any specific responsibility for residential services,' he testified.

Mr Quinn said the pain imposed on him has never gone away, adding: 'It shaped every part of who I became. It was not just a moment in time, it was the moment that stole my childhood, shattered my trust and broke something inside me that I've been trying to piece back together ever since.

Mr Quinn added that the emotional trauma he suffered, as he carried his pain for 40 years, manifested itself physically. 'I developed a stammer that I had never had before. It came from being silenced, from being terrified to speak, from knowing that no one would protect me if I did,' he said. 'That stammer has followed me

into adulthood, a persistent reminder of the silence I was

forced into, and the child I was forced to abandon to survive. For over 40 years, I have carried pain that didn't just sit quietly in the

'I was afraid to tell anyone'

background, it has been shouting inside me, every single day. I have felt angry, lost, and alone. I turned to self-medication just to try and dull the ache. I ended up in abusive relationships where people

used my past against me. I didn't know what love looked like.'

The convictions relating to Mr Farrell involve sexual assaults that took place in other areas of the school including Clohessy's office and the swimming pool changing room.

Mr Farrell, who cannot read or write, came forward after he saw Clohessy's photo in the 2018 Irish Mail on Sunday investigation.

In his victim-impact statement, which was read on his behalf by investigating garda Claire Jack-man, Mr Farrell said his life and

and then denied it under oath The denial came as Clohessy made the very unusual move of taking the stand in his second trial last month – something the jury was told does not happen in 99.9% of cases.

Clohessy did not testify in his first trial last month when he was found guilty of 14 counts of indecent assault against Gerry Quinn and Wayne Farrell, two former pupils of the St John of God school St Augustine's, in Dublin's Blackrock.

But he testified in his second trial, involving four more complain-ants, giving him the opportunity to deny allegations against him, and to call into question the credibility of his

accusers.
He used his evidence to repeatedly deny each accusation in turn, mostly with two-

word answers.

word answers.

'That's incorrect,' he said repeatedly, clearing his throat afterwards. 'Didn't happen,' he replied with a shrug to another accusation. Clohessy's calm and confident demeanour on the stand was in sharp contrast to that of his accusers. They often physically crumbled and

gave their evidence, visibly afraid of Clohessy.

One of them – Joe Devine – appeared to faint and collapsed under cross-examination by Clohessy's team, requiring an

Clohessy's team, requiring an ambulance to be called.

As a result, the second trial was delayed for the rest of that week. At times, Clohessy, who was dressed in a blue, opennecked shirt and grey jacket when he took the stand, chuckled before answering questions, as if he felt them ridiculous.

On other occasions he

On other occasions he hummed quietly to himself – a habit he displayed frequently as he sat in the dock waiting for the trial to commence each day.

But the decision to testify left him open to cross-examination by prosecution barrister Eoghan Cole, who quizzed him about his own inconsistencies.

own inconsistencies.

Asking Clohessy about corporal punishment, Mr Cole clarified: 'I am referring to punishing pupils by hitting them. Do you understand what I mean?'

'I do, yes,' Clohessy replied. 'Can I ask was there corporal punishment used in the school

during your time there or not?'
Mr Cole queried.
'No,' replied Clohessy.
'No?' queried Mr Cole.
'No,' Clohessy repeated.
'Was it used with regard to boys who were residents in the school?' Mr Cole asked.

'I'm not aware of that,' Clohessy replied. 'Sorry?' Mr Cole doubled back.

'You're not aware of that,' Mr Cole mouthed in a theatrical double-take voice, intended to flag the significance of this answer to the jury.

Mr Cole had just caught Clohessy out. The previous day, the jury had been read a tran-script of a 2019 Garda interview

with Clohessy, concerning allegations made by complainants.

In that interview, he told gar-daí: 'As principal I was responsible for everything in the school.

'Did you discipline the children with corporal punishment... did you carry it out?' he was asked. 'Only in the context of the resi-dents who I was looking after,' dents who I was looking after,' Clohessy said. Mr Cole circled back to the Garda interview towards the end of his cross-examination.
'You told the jury you never imposed corporal punishment on boys,' he asked.
'Yes,' Clohessy confirmed.
'You told the jury you never used corporal punishment yourself and you weren't actually

self and you weren't actually aware of it. Isn't that what you told the jury?' Mr Cole asked.

'Yes,' said Clohessy.
'I want you to think about that again and be sure that you are telling... that you are being as accurate as you possibly can,' Mr Cole said. 'Were there any occasions in which you imposed corporal punishment either on the state of the said. boys in the school or boys who

were in residences?'

"Sorry, what's your question?"
Clohessy queried. Mr Cole said:
'I'm asking you if you ever imposed corporal punishment
- using your strap for example
- on boys who were in the school or in the residence." Seeing his client was about to be caught out, defence barrister,Ronan Kennedy raised an objection.
In the absence of the jury, he

told Judge Martin Nolan he was concerned this line of question-ing could collapse the trial. 'There was another case,' he

or which the jury in the second trial could be told nothing.

Mr Cole argued that he was fully entitled to follow through on Clohessy's denial in this trial with weference to the 2010 Corde.

with reference to the 2019 Garda statement.

statement.
'This is about the witness's credibility to the jury,' he said.
Judge Nolan agreed.
When the jury returned, Mr Cole resumed his cross-examination. He gave a printed copy of Clohessy's 2019 interview to the accused and jury. Then he read aloud the answers in which Clohessy confirmed he'd used. Clohessy confirmed he'd used corporal punishment.
'Do you see that?' he then asked. 'Yes,' said Clohessy.

'So you told the Guards that you did invoke corporal punishment on at least some students,' Mr Cole asked.

'Yes,' said Clohessy.
'Then why did you tell the jury that you didn't?' asked Mr Cole.

'I would slap them on the bottom'

'This morning we were talking in the context of the complainants. In that context I had no responsibility for that age group,' Clohessy said.
At that, Mr Cole moved on.

With reporting restrictions in place until the conclusion of both trials, the jury in the second trial knew nothing of the previous trial – not even that it had occurred. But Mr Cole did, as did the defence and the Garda team at the back of the courtroom.

Now that both trials have concluded and Clohessy has been sentenced, matters in the first trial can be reported for the first time – including a 2022 Garda interview with Clohessy.

The voluntary and under-caution interview was conducted by top Garda interrogator Detective Sergeant Peter Woods.

Now retired, Det Sgt Woods attended both trials. In his 2022 attended both trials. In his 2022 interview with Clohessy, Det Sgt Woods asked him: 'Did you use corporal punishment?'
'I did,' Clohessy said.
'What did you do?' Clohessy was asked. 'For very, very serious offences, I would slap them on the bottom,' he answered.
'Were their clothes on or off?'

'Were their clothes on or off?'

Det Sgt Woods asked.
'On their bare bottom, yes,' said Clohessy.

'Physical abuse in school over

'Physical abuse in school over years has caused serious financial impact on my life,' he said.
'Jobs I want in life I could not have because my life was stolen from me... I wanted to be fireman or member of the Garda. That was my dream but it was stolen from me. I was so afraid to tell anyone because I didn't think they would believe me.'
Mr Farrell also described suffering from 'depression, anxiety and other health issues'.

other health issues' After the first trial verdict on May 13, Judge Duffy initially moved to remand Clohessy in cus-

moved to remand Clonessy in custody pending his sentence.
However, his barrister, Ronan Kennedy, prevented Clohessy's imprisonment on that day by arguing that the move would have delayed the second trial.

At yesterday's sentencing hearings, Clohessy's defence indicated that he would not be appealing the verdict of either case.

Clohessy's team also pleaded for leniency based on his age, his cooperative manner with gardaí, the 'antiquity' of the offences and the good work he had done in Malawi where he established a new mission for St John of God. Passing sentence in the first

'Took away their childhood'

case yesterday, Judge Duffy imposed a four-year jail sentence two years each, to be served consecutively, for each of the two victims. In doing so she commented that the crimes Clohessy had committed were 'done in

total secrecy'.
She added that Clohessy had been 'living a life which is full of good deeds during the day' while carrying out 'what can only be described as atrocities at night'. Judge Duffy also said those who

Clohessy was responsible for caring for as school principal were children who were more vulnerable than most. She added that instead of keeping them safe he had 'been the ogre who was com-

ing to them at night.'

Judge Duffy said she took on

board mitigating factors and testimonials in favour of Clohessy and his good work.
But she said she was not sen-

tencing the man who did that good work. 'I am sentencing the man who took away their childhood,' she said.

The second trial, before Judge Martin Nolan, concluded on May

Courageous victims find the strength to speak about horrific abuse they suffered

VICTIM 1 **GERRY QUINN GAVE HIS EVIDENCE ON** WEDNESDAY, MAY 7

THE tense silence in court 21 was

palpable.

No one dared breathe.

On the stand was Gerry Quinn, a grown man, aged 52, dressed in a dark green shirt and a black, patterned tie.

He'd just been asked by his own barrister to tell the court if any-thing he hadn't been happy with had ever happened with Brother Adan Clohessy while he was at school. Time ticked by in agonising slow motion. Gerry couldn't answer. He began to visibly shake.

There was only silence – as he fought for the strength to speak.

Across the room, elevated in the jury area, seven men and five women watched, transfixed at what they were witnessing.

The grown man before them was transforming before their eyes into the little boy he'd been when he first became Clohessy's victim 42 years ago.

And he couldn't get the words

Shaking, with tears running down his cheeks, Gerry scrunched up his eyes tightly. At the back of the court his

wife was in tears too.
Steeling himself to speak,
he took half a dozen long,
deep breaths, picked up
on the court microphone
before him.

Everyone watched, willing him to find the words he needed but uncertain he could.

Two steps below him – and just a couple of meters away – Clohessy, the accused, sat in the dock.

Dressed in a dark suit and olive-green, open-neck shirt, he was unable to look anyone in the eve.

Instead, head down, he found a fleck of dust on

his suit pants and flicked it off, fastidiously.

Earlier, at the start of his first trial, Clohessy had spoken the only words this jury would ever hear from him.

'Not guildty' he'd said to each of the 17 original charges against him, his distinctive Limerick twang inserting a misplaced 'D' into the

Now, as the first witness, it was

Gerry's turn to say otherwise.

He opened his eyes and tried but no words came out. Yet everyone in the room believed him already.

After an unbearable silence, prosecution barrister Eoghan Cole gen-

tly prompted him again. What had Br Aidan done? 'Stuff,' came the broken voice of a

Then another, agonising pause followed – longer this time.

It was unclear if Gerry able to do this.

'I was denied safety, trust and innocence that should have shaped my early years,' he said.

JOE Devine is a 61-year-old father-of-five who grew up in Prosperous, Co. Kildare.

One of nine children, he was sent to St Augustine's when his mother left the family home. He had just made his First Communion.

He told the court that Clohessy told him to go into the store room in the gym and 'lie across the mats.'

He said Clohessy then told him to pull his shorts down before slapping his bare buttocks with a strap.

'He took his time with the last one,' Mr

Devine told the jury.

'On the last one he said, "Hold the head straight. You needn't look back". Then he put his hands around me and said, "You've got a fine pair".

Clohessy was convicted of one of two charges of sexually assaulting Mr Devine at the conclusion of his second trial on May 30.

VICTIM 5 WHO WISHES TO REMAIN ANONYMOUS - GAVE HIS EVIDENCE ON MAY 26/27

VICTIM 5 is a 61-year-old from Dublin who was a pupil at St Augustine's in the 1970s.

He testified about being ordered by Br Aidan to remove his trousers and underwear in his office.

When he refused, he said, Br Aidan removed the clothing before slapping him with his bare hand.

He was then ordered to kneel, naked from the waist down, before a statue of St John of God.

A few minutes later he heard a noise and turned around, thinking Br Aidan was picking up keys from the desk.

He was fastening his zip, fixing his belt and tucking his shirt,' the victim testified. Br Aidan was convicted of one of four counts of sexually abusing this victim at the conclusion of his second trial on May 30.

VICTIM 6 WHO WISHES TO REMAIN ANONYMOUS - GAVE HIS EVIDENCE ON MAY 26

VICTIM 6 is a 50-year-old, originally from Co. Meath, who attended St Augustine's in the 1980s as a boarder.

He was ten years old when he began attending the school.

He testified that Br Aidan had twice sexually assaulted him in the gym

changing rooms.

He said the assaults happened as he was leaving the shower and crossing the room to get his towel

'Coming out of the shower I was touched on the backside - that happened twice,' he said.

Br Aidan was convicted of sexually assaulting this victim on two occasions at the conclusion of his second trial on May 30.

resuming, Clohessy's defence made an application to have the trial abandoned.

Addressing Judge Nolan, Mr Kennedy argued that the inci-dent, which the jury had seen, would prejudice Clohessy's defence. However, Judge Nolan allowed the trial to proceed.

In his witness statement, read by Garda Kiernan yesterday, Mr Devine said a fear of going into classrooms had resulted in a loss of education. He said he experienced feelings of 'frustration and inadequacy' and had been 'unable

even to learn the marriage vows or to read my kids a story'.

The remaining charges in the second trial relate to two other past pupils of St Augustine's who do not wish to be named.

In their impact statements, read by Garda Kiernan yesterday, they both spoke of the trauma they had lived and the flashbacks they

When he turned around, the victim testified that he saw Br Aidan zipping up his trousers, fixing his belt and tucking in his shirt.

Clohessy was convicted of this assault. He was acquitted of two other charges of assaulting this victim while the jury could not

agree on a fourth charge.
After hearing victims impact statements from these four victims yesterday, Judge Nolan said that he would decide on a sentence today. tence today.

The team prosecuting Clohessy was instructed by Liz Staunton, principal prosecutor at the Office of Director of Public Prosecutions. The Garda team was made up of members from the Garda National Protective Services Bureau.

The lead Garda investigator in the first trial was Detective Garda Claire Jackman, while the lead investigator in the second trial was Detective Garda Rachel Kiernan.

Other members of the team included Detective Carol Corrigan, Detective Deirdre O'Callaghan and Detective Sergeant Peter Woods, who is now retired. michaelofarrell@protonmail.com
