Woman, 66, charged over man's death

A WOMAN has appeared in court charged in connection with the death of a young man in a road traffic collision.

James 'Jimmy' McKenna, 25, was killed as he was walking home from a function near Moville, Donegal in the early hours of June 9,

L y n d a O'Doherty, 66, of The Links, Greencastle, is charged with driving without due care and attention thereby causing the death of Mr McKenna.

Killer fails in appeal bid on sentence

A KILLER who carried out a "vicious" and "cowardly" attack on a man who died 13 days later has failed in an appeal against his eightyear sentence.

Ian Connaghan, 35, had gone on trial in July 2023 alongside his brother Daniel Connaghan, 44, accused of the murder of Michael 'Mick' Mulvey, 55.

Both were found not guilty of murder but Ian Connaghan, from Ashington Rise, Navan Road, Čabra, Dublin 7, was convicted of manslaughter.

Dismissing the appeal yesterday, Mr Justice John Edwards said given the "sheer viciousness" and "intensity" of the attacks perpetrated on Mr Mulvey, the sentencing judge, Mr Paul Burns was correct to place it within the "high culpability" bracket.

Sources have told us the woman disappeared several years ago – and has not been seen since. It's understood investigators suspect the woman is dead and has been secretly buried.

And they suspect she was killed - but have not found enough evidence to officially upgrade her missing person's case to a murder inquiry.

"The suspicion has long been that she is dead, but there is no evidence," a source told us. "She has been missing a long time. The only credible theory is that she is dead."

Gardai have mounted repeated searches for the woman since she disappeared several years ago, but have been

unable to locate any trace of her.

It comes after gardai searched a home where she used to live - as part of an unconnected sexual abuse and neglect case that has shocked hardened officers and was first revealed by The Star.

"It is a real house of horrors case," a source told us.

We revealed that that on Monday, detectives in a Leinster town arrested

three men over the suspected sickening campaign of sexual abuse in the home. Officers believe the abuse has been

going on for years.

The three men, aged between 30s and 50s, were arrested in a town as part of a long-running Garda investigation.

Investigators fear several children at the home had been sexually abused for years at the home, as well as being neglected and assaulted.

The three suspects were questioned on offences ranging from rape and sexual abuse to neglect - and covering up the crimes. All three were released without charge last night.

Sources say officers will now prepare a file for the DPP, who will decide if anyone is to be charged.

Gardai searching the property were horrified by what they saw. "It was nothing short of squalor," a source said.

It's understood the house was littered with dirty nappies and other soiled sanitary items. Toilets were blocked and sinks were overflowing. There were also mattresses on the floor that had clear

signs of human waste on them.
"It was just horrific," one source said. As well as children allegedly being abused in the house, gardai also suspect a vulnerable adult in the same property was subjected to degrading treatment.

'PRAY FOR MY SON AFTER IRON BAR ATTACK'

THE mother of a young man fighting for life BY STEPHEN MAGUIRE after being beaten with iron bars at his own home has appealed for people to keep him in their prayers.

Charles Dooher, who is in his 20s, received a brutal bashing when a gang of five hooded men broke into his home in Lifford, Co Donegal, on Monday morning.

Charles and his father were both badly beaten at the house by the men at Coneyburrow Road close to the border with Co Tyrone at around 10.30am.

The young man was airlifted to Royal Victoria Hospital in Belfast for emergency surgery on a serious head injury.

His father Charles Snr, aged in his 60s, suffered less severe injuries and is being treated at Letterkenny University Hospital.

Charles's mother Annmarie Dooher has pleaded with family and friends to send

prayers for her son's recovery as she began a bedside vigil at her son's hospital bed.

She said on social media: "I am asking for prayers for my beautiful, brave son who fought off five men with steel batons who broke into our family home and left my son laying for dead.

"My poor son is fighting for his life and needs your prayers. I sit here desperate with my son's life in God's hands.

"I am asking you to join your hands together for my son and pray for his recovery. Pray for his beautiful, wonderful son."

Mrs Dooher added that her son did not deserve what happened to him.

She added "My son is a good man, a strong man, a hard working

man but he is still my baby.

Because of these evil people. my brave son is fragile and fighting for his life."

A full Garda investigation has been launched into the brutal attack while CCTV footage from the surrounding area has been harvested as part of the investigation. Gardaí are appealing for

any witnesses to this incident to come forward.
